

TRAVEL REBATE FACT SHEET

Off the Track WA Travel Rebate fact sheet for applicants

1. TRAVEL REBATE

Off the Track WA provide a 30% subsidy off entry fees, not exceeding \$75.00 per horse/rider combination, for OTTWA competitors who travel 150km or more to attend the event with a retired racehorse. (Please see table below) This is a great opportunity to gather more entrants via a reduced entry cost subsidized by OTTWA. This subsidy applies exclusively to entry costs and does not cover ground fees, start levies, medical fees, or any other associated charges. This is an 'opt in' process that requires you to coordinate the administration items as per Section 2.

2. RESPONSIBILITIES

- Include a postcode option within your entry form to be used to calculate eligibility.
- Record eligible OTT entrants that fit within the over 150km travel range.
- Email the eligible entrants including rider name, horse race name, horse show name, horse passport (H0) number and rider post code, to offthetrackwa@rwwa.com.au
- Reimburse riders 30% of their entry cost if found to be eligible, up to the maximum value of \$75.00 per horse/rider combination.
- Invoice Racing and Wagering WA for the reimbursement of this subsidy.

Despite 30% of Jen Bloggs' entry fee being \$97.65, the capped limit is \$75.00 per horse/rider combination.

3. PROCESS

For ease of administration, Off the Track WA advises that the details required in Section (2) be requested upon entry by the competitor.

Event organisers are to ensure that they calculate the distance from the event to the competitors residential address and approve eligibility.

Details are to be emailed through to OTTWA no later than two weeks post event and are a requirement prior to submitting the travel rebate invoice. Once this has been approved by OTTWA, the invoice can be submitted directly to invoicesap@rwwa.com.au and must state your purchase order number and final rebate amount.
